Franklin County Animal Rescue (FCAR) is the only shelter in almost 900 square miles of northwestern Vermont. A shelter's live release rate is the recognized gold standard of a shelter's lifesaving work. The outcomes achieved for dogs and cats at Franklin County Animal Rescue exceed Vermont and national averages. Franklin County Animal Rescue's performance for eight years ranges from 95% to 98% live release, based on data from the national Shelter Animals Count database and Best Friends Animal Society. That's far above the 90% save rate considered no kill. Community support is strong as demonstrated by more than 120 active volunteers; more than 1,200 annual donors See Part III, Ln 4a statement
